#### Appointing a nominated representative

- 6.1 By signing this authority form to request the appointment of an individual as a nominated representative, you acknowledge and agree that:
  - a. we may accept instructions from the nominated representative to give, amend and manage authorisations to share CDR data with accredited data recipients about the Entity's accounts specified in Section 4 of this authority form
  - b. the nominated representative may initiate and manage CDR data sharing via a request made by an accredited data recipient
  - c. the Entity's CDR data will be shared in accordance with the Australian Government Consumer Data Right legislation, rules and standards
  - d. acting reasonably, we reserve the right to cancel or suspend this authority form at any time without prior notice including where:
    - we consider it necessary to prevent physical or financial harm or abuse
    - we're required by law or court order or requested by any regulatory body, law enforcement or other government agency, or
    - we determine there is another reasonable cause, including those related to compliance, technical or security issues to protect our CDR service, and
  - e. we're entitled to rely on this authority form until such time that you provide us with instructions to revoke the nominated representative's authority.

### Terms and conditions (continued)

#### Revoking a nominated representative

6.2 By signing this authority form to request the revocation of a nominated representative, you acknowledge and agree that:

- a. by providing instructions to 'Revoke' as set out in Section 1 of this authority form, the individual listed in Section 3 above will be removed as a nominated representative and will no longer be able to give, amend and manage authorisations to share CDR data on behalf of the Entity, and
- by providing instructions to revoke all existing data sharing authorisations in Section 3 above, any existing authorisations set up by the nominated representative listed in Section 3 to share CDR data with accredited data recipients will be revoked.
  If we do not receive these instructions, any existing authorisations will expire within the timelines specified in the Australian Consumer Data Right legislation, rules and standards.

#### General

6.3 By signing this authority form, you acknowledge and agree that:

- a. you indemnify us against any claim, loss, damages or costs suffered or incurred by us as a result of us acting reasonably, in accordance with this authority form. This includes any losses or damages incurred as a result of breaches of privacy or confidentiality, or fraud caused, or contributed to, by a nominated representative's authorisations to share CDR data on behalf of the Entity. However, we remain liable for any loss or liability which is due to our negligence or fraud, or which, by operation of law we cannot exclude
- b. this indemnity survives revocation of this authority form, and
- c. you have done all things necessary, including obtaining any approvals or corporate authorisations, to enter into this authority form.
