

# Home loans identification form

### For our home loan brokers

- Please note, this form should only be used when your client is unable to complete our digital ID solution, NextGenID. NextGenID is now the primary path for Macquarie Home Loan brokers to verify their client's identity resulting in cleaner
- applications and faster time to approval. For more information, visit the Broker Help Centre.
- If your client is unable to complete their verification of identity digitally, follow the instructions below to complete the Home Loan Identification form via an in-person interview.

#### How to complete this form

- Complete one form for each person being identified.
- The person being identified ("the interviewee") needs to have an in-person interview with a qualified witness ("the interviewer") and provide original identification documents ("ID documents") from one of the categories listed in 2. Details of Interviewer.
- The original ID documents:
- need to be sighted and certified by the interviewer, see *Guide 1: How to certify documents*
- must be current and not expired (except Australian Passport if the passport has expired in the last two years and has not been cancelled)
- the interviewee's name on all ID documents must match the name used on the loan application and any government issued Marriage or Change of Name Certificate must also be provided.
- Once completed, provide the signed form with the application documents along with certified copies of the ID documents.

1. Note: If any ID documents are not in english, they'll need to be accompanied with a translation certificate from an Australian registered and licensed translation service prior to certification. Marriage certificates must be government issued (e.g. NSW Registry of Births, Deaths, and Marriage). Ceremonial marriage certificates will not be accepted.

## Guide 1: how to certify documents

Each document must be certified separately and must show clearly:

- the words "certified true copy of the original"
- the signature of the certifying officer
- the name, address, contact telephone number, provider/registration number (if applicable) and profession of the certifying officer, legibly printed below the signature; and
- the date the document was certified

Persons who may certify documents for the Lender include:

- an officer with, or a credit representative of, a holder of an Australian credit licence, having 2 or more years of continuous service with one or more licensees;
- a person who is enrolled on the roll of the Supreme Court of a State or Territory, or the High Court of Australia, as a legal practitioner;
- 3. a judge of a court;
- 4. a magistrate;
- 5. a police officer;
- 6. a chief executive officer of a Commonwealth court;
- 7. a registrar or deputy registrar of a court;
- 8. a clerk of a court;
- 9. a Justice of the Peace;
- 10. a Commissioner for Affidavits or Declarations;

- 11. a notary public;
  - an agent of the Australian Postal Corporation who is in charge of an office supplying postal services to the public;
  - a permanent employee of the Australian Postal Corporation with 2 or more years of continuous service who is employed in an office providing postal services to the public;
  - 14. an Australian consular officer or an Australian diplomatic officer (within the meaning of the Consular Fees Act 1955);
  - a bank or building society officer with
    2 or more continuous years of service;
  - an officer with, or authorised representative of, a holder of an Australian financial services licence, having 2 or more continuous years of service with one or more licensees.
